1. RE PARA 2 MEXI 1011, ODENVY SHOWED HER SPREAD BUT SUBJECT PHOTO ONLY ONE WHICH ATTRACTED ATTENTION. COMMISSION ADAMANT NEEDS PHOTO TO ESTABLISH DOUBT OTHER PHOTOS WILL BE PUBLISHED. ODENVY TOLD HER NOTHING RE IDENTITY OR ORIGIN OF PHOTO.

CHAIN OF EVIDENCE

2. RE PARA 5 MEXI 1011, THERE WILL BE NOTHING IDENTIFIABLE WITH OR ATTRIBUTABLE TO LIFEAT OR LIENVOY.

3. WE HAVE ASSURANCE FROM COMMISSION STAFF THAT BACKGROUND DETAILS OF PHOTO WILL BE OBSCURED SATISFACTORILY.

4. NEVERTHELESS, BELIEVE PRUDENCE DICTATES EQUIPMENT SHOULD BE REMOVED FROM INSTALLATIONS INCLUDING LIMESA PER PARA 3 REF AND THAT SAFEHOUSE KEEPERS CONTINUE NORMAL PATTERN.

5. WILL CONTINUE KEEP YOU POSTED ON DEVELOPMENTS.
