Mrs. EVA GRANT, 3529 Rowline Street, telephone LA 6-6220, voluntarily advised that on July 24, 1964, Mrs. WILMA TICH telephoned her during the afternoon and asked if she could come to Mrs. GRANT's apartment. She said she invited her to come and Mrs. TICH appeared shortly thereafter.

Mrs. TICH related to Mrs. GRANT that she had given a deposition to the President's Commission on the same date. She said she and her husband had left their children at a theatre and at a time when they went to the theatre to pick the children up she, Mrs. TICH, had run away from her husband, who had threatened her. Mrs. TICH spent approximately four hours in Mrs. GRANT's apartment.

Mrs. GRANT stated she considers Mrs. TICH is "balmy," is "gun out" because she was not more closely associated with the events of the assassination, and is seeking publicity. She said she believes the Commission can "discount" anything Mrs. TICH may have told them. She said, however, Mrs. TICH, in claiming she had seen RUBY at Parkland Hospital on November 22, 1963, had rather accurately described the clothing RUBY was wearing. She repeated that she believes Mrs. TICH is "balmy."
